 - g. Section 610.021(12)-Sealed bids and related documents, until the bids are opened; and sealed proposals and related documents or documents related to a negotiated contract until a contract is executed, or all proposals are rejected;
 - h. Section 610.021(13)-Individually identifiable personnel records, performance ratings or records pertaining to employees or applicants for employment;
 - i. Section 610.021(14)-Records which are protected from disclosure by law;
 - j. Section 610.021(17)-Confidential or privileged communications between a public governmental body and its auditor, including all auditor work product.
