# Fiscal year 2024 CAPE GIRARDEAU COUNTY REORGANIZED COMMON SEWER DISTRICT RATES AND FEE SCHEDULE

Note: While Rates and Fees are usually adjusted once a year at the May Board meeting, they can be adjusted at any time throughout the year if necessary.

## **RATES**

## A. New Residential Customer

\$74/month

- a. Based on a \$45 Service Availability Charge plus the Metered Charge for an average of 4175 gallons of water used.
- b. New Residential Customer charge applies when the 3-month average usage is not available, cannot be determined because water is not metered, or metered water amount does not correspond to sewer flow because of outside water usage.
- B. Established Residential Customer
  - a. \$45 Service Availability Charge plus the Metered Charge
  - b. After a new customer has a 3-month winter water usage established, their residential bills are typically calculated in May based on the average of the 3-month previous winter water usage, and that bill is set for the entire subsequent fiscal year.
- C. Multi-Unit Residential, exception to the one-meter per residence scenario
  - a. Billed monthly as a commercial customer, where one meter serves 3 or more residential units, or, billed as a residential customer using the winter water usage where one meter serves 2 residential units.
  - b. Consists of a Service Availability Charge of \$40 multiplied by the number of residential units, plus the Metered Charge
  - c. 6 properties are grandfathered as of December 1, 2022, at the normal Residential or Commercial Customer rates until the ownership changes. These properties are listed at the District Office.

- D. Commercial Customer
  - a. \$45 Service Availability Charge, plus
  - b. The Metered Charge calculated monthly, instead of once a year
- E. Vacant Property Charge
  - a. Vacant charge is assessed on vacant properties when the water is still connected, and will be calculated monthly the same as a Commerical Customer.

F.	Metered Charge	\$7/1000 gallons

G. Residential Deposit for renters \$100

H. Residential Deposit for homeowners living in their home \$0

- a. Homeowners in good standing are not required to make a \$100 deposit.
- I. If any customer's water is shut off who doesn't have a deposit, then a deposit may be required in order to have the water reconnected, in addition to other fees and penalties.
- J. Deposit may be refunded after a 3-year good payment history.

  - ii. New Connection Fee to forcemain sewer in Saddlebrooke Ridge per 7.9.2019 connection fee resolution, when a forcemain tap exists; the sum of:
    - 1. Actual cost of District-owned equipment, plus
    - 2. Average cost of District installation of \$2000
    - 3. Totals \$7,590

  - 5. Additional, actual charges will apply where no forcemain tap and valve pit exists and/or when grinder pump is over 200' from the forcemain.
